In the following school year, she and other Newton participants will be called up to describe to the Newton community through presentations, articles, etc. what they have learned from the program.

Barry Boys & Girls Club or other sponsoring organization will have a conversation with me to address any questions about the program and to ensure that I understand that Envision the Future is a residential STEM program for girls 11-13 years old and requires that my daughter stay overnight at Bridgewater State University for 4 nights.
- If my daughter is selected to participate:
 - I will contribute a non-refundable \$50 by May 22, 2015 for her to attend.
 (The total cost for each participant to attend is \$550, which will be covered by the \$50 parent/guardian contribution plus a \$500 scholarship contributed by the John M. Barry Boys & Girls Club for each participant selected.)
 - o I will complete the program's authorization forms (medical, photo release, field trips, etc.)
 - I will be responsible for my daughter's transportation to the program on July 20, 2015 and from the program on July 24, 2015.
